The BSPL Shield Final between St. matts and Rushlight Celtic was eventually played at Allen Park on the 9th March, 2003.



YOU HAVE BEEN WARNED

With the First and Second Division League Titles still being disputed as well as promotion and relegation, I feel that it is incumbent upon ourselves in the Committee to remind all clubs that should any team reach 60 disciplinary points they wil **automatically** lose 2 league points.

Upon reaching 65, a further League point would be deducted, with one point being lost every five disciplinary points received after that.

A look at the fair play League would see that it would not be impossible for teams to miss out on titles or promotion or be relegated should they "Lose the Plot" in their remaining matches.
